

**ORDINANCE NO.** 184335

\* Amend subrecipient contract with American Red Cross for an additional \$50,000 to continue operating severe weather warming centers for people experiencing homelessness. (Ordinance; amend Contract No. 32000263)

The City of Portland ordains:

SECTION 1. The Council finds that:

1. The Portland Housing Bureau (PHB) entered into Subrecipient Contract No. 32000263 with the American Red Cross, Oregon Trail Chapter (Red Cross) to operate severe weather warming centers for people experiencing homelessness. These warming centers provided expanded shelter capacity of 150 – 300 beds per night during up to 15 nights during FY 2009-10 on which forecasted weather conditions posed an immediate danger to the life and health of unsheltered people.
2. Amendment 1 to Subrecipient Contract No. 32000263 extended the end-date of contract to include FY 2010-11.
3. Funding in the amount of \$50,000 in City general funds will be added to this contract through amendment for a total two-year not to exceed amount of \$125,000 through the allocation of existing appropriations for this purpose in PHB's FY 2010-11 Ending Homelessness Initiative budget.

NOW, THEREFORE, the Council directs:

- a. The Bureau Director and the City Auditor are hereby authorized to amend Subrecipient Contract No. 32000263 with the Red Cross in accordance with the amendment attached as Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to make payment chargeable to the FY 2010-11 budget when demand is presented and approved by the proper authority.


