## ORDINANCE NO. 184336

\* Amend subrecipient contract with Housing Authority of Portland for an additional \$22,600 to administer additional short-term rent assistance for homelessness prevention and rapid rehousing. (Ordinance; amend Contract No. 32000138)

The City of Portland ordains:

## SECTION 1. The Council finds that:

- 1. The City of Portland passed Ordinance No 183296 authorizing Subrecipient Contract No. 32000138 with the Housing Authority of Portland (HAP) to operate the Short-Term Rent Assistance (STRA) program, which provides homelessness prevention and rapid rehousing activities through a network of 19 community based agencies.
- 2. The City of Portland passed Ordinances Nos 183608 and 184025 authorizing amendment of Subrecipient Contract No. 32000138 to extend the contract duration and funding to provide additional homelessness prevention and rapid rehousing activities.
- 3. Funding in the amount of \$22,600 in Federal Homelessness Prevention and Rapid Rehousing Program (HPRP) administrative funds from the American Recovery and Reinvestment Act (ARRA) will be added to this contract through amendment for a total two-year not to exceed amount of \$4,895,665 through the allocation of existing appropriations in PHB's FY 2009-10 Ending Homelessness Initiative budget.
- 4. The additional funds will be used to administer homelessness prevention and rapid rehousing activities through June 30, 2011.

## NOW, THEREFORE, the Council directs:

- a. The Bureau Director and the City Auditor are hereby authorized to amend Subrecipient Contract No.32000138 with HAP in accordance with the amendment attached as Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to make payment chargeable to the FY 2010-11 budget when demand is presented and approved by the proper authority.

SECTION 2. The Council declares that an emergency exists because the program funds must be obligated within required timeframes; therefore, this ordinance shall be in force and effect from and after its passage by Council.
