

**ORDINANCE No. 184349**

\*Accept and appropriate a grant in the amount of \$94,710 from Corporation for National Service for five Americorps VISTA volunteers (Ordinance)

The City of Portland ordains:

**Section 1. The Council finds**

1. Mayor's Office applied to Corporation for National Service for a grant in the amount of \$94,710.00 for five Americorps VISTA volunteers on 12/15/2010; and
2. Corporation for National Service has notified the City of Portland that it will award a grant for the Americorps VISTA to the Mayor's Office and Portland Parks and Recreation in the amount of \$94,710.00;

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Mayor's Office for the Future Connect Vista Project in the amount of \$94,710 for 5 Vista positions.
- b. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.


