7. BACKGROUND/ANALYSIS

This Ordinance settles a fleet bodily injury lawsuit for \$180,000. Risk Management previously paid \$20,000 (by Ordinance No. 183567) to Safeco Insurance to reimburse it for medical expenses paid on the claimant's behalf, so the total settlement for this injury claim is \$200,000.

The lawsuit against the City arose from an automobile collision that occurred on June 12, 2008, near the intersection of North Larabee and North Dixon. Ms. Woloshin was stopped on N. Larabee to make a left turn, and was rear-ended by a Water Bureau employee driving a city truck. Liability on the part of the City is clear; the collision was the sole fault of the city's driver.

The lawsuit against the City was filed by attorney Gary Kahn, and has been defended by attorney Jim Rice of the City Attorney's Office. Extensive pretrial discovery was completed, including independent review of medical records. Based on evaluation of the claim by the City Attorney's Office and Risk Management, we recommend that this lawsuit be settled for \$180,000.

8. FINANCIAL IMPACT

Approval of the settlement will result in a payment of \$180,000 from the liability fund.

9. RECOMMENDATION/ACTION REQUESTED

Approve settlement of Mara Woloshin bodily injury lawsuit in the sum of \$180,000.
