## ORDINANCE N₀. 184369

\*Accept a grant in the amount of \$326,226 from the Washington State Department of Transportation for the Columbia River Crossing (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

- 1. The Bureau of Transportation applied to Washington State Department of Transportation for a grant in the amount of \$326,226 the Columbia River Crossing; and
- 2. The Washington State Department of Transportation has notified the City of Portland that it will award a grant for the Columbia River Crossing to the Bureau of Transportation in the amount of \$326,226;

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Washington State Department of Transportation for the Columbia River Crossing in the amount of \$326,226 and to execute an intergovernmental agreement in substantially the form of the attached exhibit for this purpose.
- The FY 2010/2011 budget is hereby amended as follows: <u>GRANTS FUND</u> Fund 217 Business Area – TR00 Bureau Program Expenses – \$326,226
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
