The City of Portland ordains:

Section 1. The Council finds:

1. Jeff Morris Fire & Life Safety Foundation (JMF&LSF) received a donation from the Fireman's Fund Insurance to be used toward the costs of an arson dog.
2. JMF&LSF would like to donate \$6,694.37 to Portland Fire & Rescue
3. The Fire Chief recommends that the Council accept the donation from Jeff Morris Fire & Life Safety Foundation.


