

## ORDINANCE NO. 184387

Amend contract with Analytical Services, Inc. to increase compensation for laboratory services for Cryptosporidium Analysis (Ordinance; amend Contract No. 30000364)

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland Water Bureau entered into a contract with Analytical Services, Inc. under Ordinance 182551 to work with City staff to design a sampling plan and perform the associated sample analysis in order to obtain a variance to the treatment requirements of the Environmental Protection Agency (EPA)'s Long Term 2 Enhanced Surface Water Treatment Rule (LT2).
2. The Water Bureau completed the sample analysis and study and is preparing to submit a variance request. It is anticipated that this process could last as long as a year or more, during which time the Water Bureau intends to continue monitoring source water to meet what the EPA has outlined as the likely minimum conditions of a variance.
3. Further analysis of source water monitoring beyond the initial scope of the contract, as written for the LT2 variance sampling, is required to continue source water monitoring for pathogens while the Water Bureau prepares and submits a variance request.
4. As part of the year-long LT2 variance sampling program, a sampling method modification was researched to improve the effectiveness of analyses. The method modification has undergone a Tier 1 validation specifically for Portland's source water. As this validation is laboratory specific, it is important that the Water Bureau continues to work with ASI to avoid another lab needing to seek validation for the method modification.
5. The contract will be amended to increase funding by \$800,000. The contract was previously amended by \$50,000, and then \$575,000 under Ordinance 183690. The new contract total will be \$1,625,000. Funding will be requested in the Spring BuMP.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge and Auditor are authorized to execute on behalf of the City an amendment to Contract No. 30000364 with Analytical Services, Inc. as outlined in a form substantially in accordance with the contract amendment attached as Exhibit 1, at a cost not to exceed \$1,625,000.

- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Water Fund when demand is presented and approved by the proper authorities.
