

ORDINANCE No. 184392

\* Amend contract with Cascade Occupational Medicine to provide medical examinations for anticipated new hires (Ordinance; amend Contract No. 30000994)

The City of Portland ordains:

Section 1. The Council finds:

1. On July 1, 2009, Portland Police Bureau and Cascade Occupational Medicine entered into an agreement in an amount not to exceed \$37,102 to provide medical examinations to anticipated new hires to the position of community police officer.
2. The term of the agreement was July 1, 2009 through December 31, 2010.
3. PPB and Cascade Occupational Medicine wish to amend the agreement and extend the term to July 31, 2012 and add \$30,000 to the agreement for a total not to exceed amount of \$67,102.
4. The extension allows adequate time for the Police Bureau to complete a Request for Proposal for future medical services and evaluations.

NOW, THEREFORE, the Council directs:

- a. The Mayor and Auditor are hereby authorized to amend the agreement substantially in accordance with the agreement attached as Exhibit A.

Section 2. The Council declares an emergency exists because delay in proceeding with this amendment will unnecessarily deprive the City and Cascade Occupational Medicine of the mutual benefits of the amendment. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
