

ORDINANCE NO. 1843 93

* Accept donation of a horse for the Police Bureau Mounted Patrol Unit from Kathryn Kleinwachter (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Kathryn Kleinwachter would like to donate a horse to the Police Bureau Mounted Patrol Unit (MPU).
2. MPU has completed a 60 day trial period of the horse and would like to accept the horse as a donation.
3. The Chief of Police recommends that the Council accept the horse donation from Kathryn Kleinwachter.

NOW THEREFORE, The Council directs:

- a. The City Council accepts the donation of a horse and thanks Kathryn Kleinwachter for her donation.

Section 2. The Council declares that an emergency exists because delay in accepting this donation will unnecessarily deprive the City and the Mounted Patrol Unit of the benefits of the donation. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.


