Subrecipient Contract No. 32000393

Amendment No. 1

This subrecipient contract ("Contract") between the City of Portland, acting by and through its Portland Housing Bureau ("PHB"), Office of Management and Finance ("OMF"), and the Portland Development Commission ("PDC" and "Subrecipient") is hereby amended as follows:

I. Section III. Compensation and Method of Payment on page 4 is deleted in its entirety and replaced to read:

III. <u>COMPENSENTATION AND METHOD OF PAYMENT</u>

PHB and OMF shall provide the following funding to PDC for performance of the work described in the Scope of Work above:

A. PHB will provide PDC with a total of \$3,218,159 in CDBG:

1. FY 2010-2011 Entitlement:	\$2,845,310
2. FY 2009-2010 Carryover in Spring BMP:	\$350,000
3. FY 2009-2010 Carryover in Fall BMP:	\$22,849

B. PHB will provide PDC with a total of \$507,212 in CDBG-ARRA:

- C. PHB will provide PDC with a total of \$5,000 in Eli Lilly Grant, FY 2009-10 Carryover in Winter BMP.
- D. OMF will provide PDC with a total of \$1,399,644 in FY 2010-2011 On-Going City General Fund.
- E. The total compensation shall not exceed FIVE MILLION, ONE HUNDRED THIRTY THOUSAND, and FIFTEEN DOLLARS (\$5,130,015)
- F. Final invoice is due on July 11, 2011.
- G. PHB and OMF shall pay all compensation to PDC under this Agreement on an expense reimbursement basis, for CBDG, CDBG-ARRA, Eli Lilly Grant, and General Fund expenses identified in the Budget, attached hereto as Exhibit B, and reasonably incurred by PDC in performing the work described in the Scope of Work. Requests for expense reimbursement shall be submitted and processed as described in Section H and I below.
- H. PDC shall submit requests for expense reimbursement from the CDBG, CDBG-ARRA, and Eli Lilly Grant sources in the form of Exhibit C attached hereto, to PHB monthly for expenses accrued in the prior calendar month. PHB will review, modify if necessary, approve, and then forward them to the OMF Contract Manager in the Financial Planning Division in OMF for
 payment. Periodic reimbursement requests between monthly billings may be

submitted on an interim basis as approved by both PDC and PHB. PHB shall make payment to PDC within 30 business days of receiving a billing. If for some reason payment cannot be made due to errors or omissions then PHB will request from PDC a corrected billing within the 30 day period. The request for corrected billing shall detail all deficiencies in the billing which have caused payment to be withheld.

- I. PDC shall submit requests for expense reimbursement from the General Fund sources in the form of Exhibit D attached hereto, to OMF monthly for expenses accrued in the prior calendar month. OMF will review, modify if necessary, approve, and then make payment. Periodic reimbursement requests between monthly billings may be submitted on an interim basis as approved by both PDC and OMF. OMF shall make payment to PDC within 30 business days of receiving a billing. If for some reason payment cannot be made due to errors or omissions then OMF will request from PDC a corrected billing within the 30 day period. The request for corrected billing shall detail all deficiencies in the billing which have caused payment to be withheld.
- II. Exhibit B, Budget 2010-2011, and Exhibit C, Sample Invoice are deleted in their entirety, replaced, and attached as Exhibit B and C to this Amendment.
- III. All other terms and conditions of the Contract remain the same.
