The City of Portland ordains:

Section 1. The Council finds:

- 1. The Jeff Morris Fire & Life Safety Foundation is organized, among other things to perpetuate the spirit of Jeff Morris through the development and delivery of fire and life safety education, thus ensuring the safety and welfare of citizens through education, training, and technology. The Foundation will also strive to preserve and present the history of Portland Fire & Rescue for today and into the future.
- 2. The Jeff Morris Fire & Life Safety Foundation accepts charitable donations for this purpose, including from employees of Portland Fire & Rescue.
- 3. The Jeff Morris Fire & Life Safety Foundation is classified as a public charity under section 501(c)(3) of the Internal Revenue Code.
- 4. The Jeff Morris Fire & Life Safety Foundation has expressed an interest in being added to the list of those organizations eligible to use the payroll deduction system under Code Section 5.08.140 Salary Deduction.
- 5. It is in the City's interest to add the Jeff Morris Fire & Life Safety Foundation to the list of those organizations eligible to use the payroll deduction system not required to pay the fee described in Subsection 5.08.140 B.

NOW, THEREFORE, the Council directs:

- a. The Mayor and Auditor are hereby authorized to add the Jeff Morris Fire & Life Safety Foundation to those organizations eligible to use the payroll deduction system not required to pay the fee described in Subsection 5.08.140 B.
- b. City Code 5.08.140 shall be amended as described in Exhibit A.
