* Authorize an Intergovernmental Agreement with Portland State University for \$12,000 for support of the First Stop Portland program for logistic and planning services for visiting delegations (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

1. The public interest of the citizens of the City of Portland is served by a coordinated program hosting visiting delegations interested in Portland's sustainability and livability practices.

2. Portland State University, through the College of Urban and Public Affairs (PSU CUPA) manages a program called First Stop Portland that provides logistics and planning services to these delegations, thus relieving city staff of this responsibility.

3. The City's financial assistance of \$12,000 to PSU CUPA for this program is consistent with City authority and functions under its Charter.

4. The City wishes to enter into an Intergovernmental Agreement, Exhibit A attached, with PSU CUPA to provide logistics and planning services to visiting delegations interested in Portland's sustainability and livability practices.

NOW, THEREFORE, the Council directs:

a. The Mayor is hereby authorized to execute an intergovermmental agreement for \$12,000 in one-time funds with PSU CUPA substantially similar to that attached as Exhibit A to this ordinance.

b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the General Fund upon the passage of this ordinance.

Section 2. The Council declares that an emergency exists to avoid a delay in providing funding to PSU CUPA; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
