Amend contract with Skylab Architecture LLC for additional work and compensation for the Columbia Boulevard Wastewater Treatment Plant Support Facility Project No. E09023 (Ordinance; amend Contract No. 30001585)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) has a need of continuing professional architectural and engineering services provided by Skylab Architecture LLC for the completion of design, permitting, and construction support services for the Columbia Boulevard Wastewater Treatment Plant (CBWTP) Support Facility, Project No. E09023.
- 2. Skylab Architecture LLC is providing professional architectural and engineering services under Contract No. 30001585, effective on August 2, 2010 with an expiration date on October 2, 2013.
- 3. Contract Amendment No. 1, in the amount of \$83,811, added consultant services to update the 2004 CBWTP Conditional Use Master Plan.
- 4. This Amendment No. 2 will authorize additional work for design of site development improvements in the amount of \$338,186 for a new not-to-exceed contract amount of \$943,923.
- 5. The estimated cost of this contract amendment is \$338,186. Funds are available in the Sewer System Operating Fund, FY 2011 Budget, Bureau of Environmental Services Project No. E09023.
- 6. M/W/ESB participation after the authorization of this contract amendment will be \$497,764.00, 52.73% of the total amended contract amount of \$943,923.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute an amendment to Contract No. 30001585 with Skylab Architecture LLC, in a form substantially in accordance with the amendment attached as Exhibit A, for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


