

# ORDINANCE No. 184440

\*Authorize application to Oregon Parks & Recreation Department for a grant in the amount of \$750,000 for land acquisition in the Willamette Watershed (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Parks & Recreation's (PP&R) 2020 Vision plan calls for PP&R to work with other City agencies and private property owners to improve the natural resource quality of riparian areas on the Willamette River and its tributaries.
2. PP&R identified high priority natural areas in the Willamette Watershed for acquisition. Purchase and protection of this natural area will help PP&R and the Bureau of Environmental Services (BES) to meet water quality and habitat goals.
3. PP&R will accept management responsibility for the property once acquired. Stabilization will begin immediately; no additional O&M funds will be requested for FY 2011-12.
4. City Council approval will be sought before actual purchase of the property in late spring 2011.
5. The Oregon Parks & Recreation Department (OPRD) offers grant funding for land acquisition. Portland Parks & Recreation has prepared a grant application to submit to OPRD requesting grant funds for acquisition of natural area lands in the Willamette Watershed.
6. The grant from OPRD requires a minimum 50% match. A minimum local match in the amount of \$375,000 will be provided by funds from the FY 2011-12 proposed budget of BES and PP&R for land acquisition. These funds are available in the Sewer System Operating Fund, BES, WBS element E08905, and PP&R's Local Share of the Metro Natural Areas Bond, WBS element P00493.


NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to make an application to the Oregon Parks & Recreation Department for a grant in the amount of \$750,000.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for

- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists as the application must be delivered by April 8, 2011; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
