ORDINANCE No. 184444

Adopt fees for extreme economic hardship exemption applications under Containers in the Right of Way rules. (Ordinance.)

The City of Portland ordains:

Section 1. The Council finds:

1. PCC 17.102.290 authorizes the Bureau of Planning and Sustainability to enforce violations related to the prohibition of storing solid waste, recycling or compostable containers in the public right-of-way.
2. PCC 17.102.290 permits the Bureau of Planning and Sustainability to charge fees to business and property owners who apply for an extreme economic hardship exemption to recover costs of administering the exemption program.
3. PCC 17.102.290 states that the fees are stated in a fee schedule adopted by City Council. Staff recommends that the City Council approve the fee schedule that is shown in Exhibit A.


NOW, THEREFORE, the Council directs:

- a. The Bureau of Planning and Sustainability shall follow the fee schedule attached as Exhibit A to this Ordinance in administering the City's regulations for Containers in the Right of Way as set forth in PCC 17.102.290.
