## I. RECOMMENDATION

It is requested that the ordinance to authorize the amendment to contract with DMC be placed on the Consent agenda and approved by Council.

## II. BACKGROUND

By Contract No. 51720, DMC developed and provided FPDR with systems design and programming services. By Ordinance Nos. 180908 and 181485, the contract was amended to extend the period of the contract period and/or increase the compensation amount. While DMC's contract will expire on December 31, 2012, additional compensation amounts are necessary to continue the contract. As a result of changes to the tax laws under the economic stimulus plan, there were some major software changes that needed to be made with regard to editing tax tables, adding tables, and creating new screens. In addition, DMC will be working on implementing programming to process FPDR's collection of funds as a result of the IRS's Voluntary Compliance Program regarding the FPDR's tax qualified status. DMC will be adding new fields, providing a way to calculate overpayments, tracking the recovery of the overpayments and modifying screens. DMC continues to also provide regular monthly maintenance, security and other upgrades. Additional compensation in the amount of \$50,000 is requested.
