WHEREAS, the park is located in the Lents Neighborhood, between SE 88th and 92nd, SE Holgate, and SE Steele; and

WHEREAS, the 38-acre park is large enough to accommodate a variety of active and passive recreational opportunities that will serve the city and the immediate neighborhood; and

WHEREAS, the neighborhood is changing in character and increasing in density; and

WHEREAS, the park has been designed and constructed in phases, with the earliest five-acre portion constructed in 1914, construction of the remaining 38-acre site in 1953, and further construction occurring in the early 1980s after completion of the 1981 Lents Park Report; and

WHEREAS, the plan was prepared with an advisory committee comprising representatives from the Lents Neighborhood Association, Lents Town Center Urban Renewal Advisory Committee, Foster Area Business Association, Rose Community Development Corporation, Friends of Lents Park, SE Works, Parks Board, and members at large; and

WHEREAS, there were three public open houses, three public comment periods, three listening sessions, and stakeholder interviews to gather public input during the project.

NOW, THEREFORE, BE IT RESOLVED, that the City of Portland, a municipal corporation of the State of Oregon, affirms its acceptance of the 2011 master plan for Lents Park as the city's guide to the future development of the park.
