ORDINANCE No. 184508

* Amend contract with Central City Concern to increase payment in an amount not to exceed \$150,000 to support the services of the Sobering Station (Ordinance; amend Contract No. 30001709)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Central City Concern (CCC) operates the Hooper Detoxification Center's Sobering Station and Hooper's CHIERS roving response van.
- 2. The outreach and sobering programs provided by the Sobering Station and CHIERS van perform a significant public service, improve public safety, and keep Portland's vulnerable safe.
- 3. Portland Police bring intoxicated people to Hooper's Sobering Station to sober up rather than taking them to jail. This provides a safer and more appropriate environment than the county jail.
- 4. The City executed Contract No. 30001709 on October 13, 2010 with Central City Concern for the amount of \$432,180 for CHIERS and \$478,897 for the Sobering Station Program for a total not to exceed amount of \$911,077.
- 5. Funding from area hospitals was withdrawn for FY 2010-11, leaving a shortfall to cover the cost to operate the Sobering Station.
- 6. Council approved \$150,000 in Special Appropriations in the FY 2010-11 Adopted Budget for the purpose of providing additional support for the services of the Sobering Station program.
- 7. The amended total funding specific to the operation of the Sobering Station will increase by \$150,000 to \$628,897, and the total contract amount not to exceed \$1,061,077.

NOW, THEREFORE, the Council directs:

- a. The Mayor and Auditor are hereby authorized to amend Contract No. 30001709 substantially in agreement with the attached Exhibit A.
- Section 2. The Council declares an emergency exists because delay in proceeding with this amendment will unnecessarily deprive the City of Portland and Central City Concern of the mutual benefits of this amendment. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
