ORDINANCE No. 184509

*Authorize a contract and provide for payment to replace three dump trucks for \$510,000. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The CityFleet Division of the Bureau of Internal Business Services replaces all City vehicles based on an annual replacement plan.
- 2. CityFleet has reviewed the standard replacement schedule and the condition of the 12-15 yard dump trucks used by Bureau of Environmental Services (BES).
- 3. CityFleet has reviewed the 2011 replacement schedule and the condition of Bureau of Environmental Services 12-15 yard dump trucks (vehicles #984209, #984210, and #984211) and has determined that the three dump trucks need to be replaced and that the request is appropriate. The trucks are beyond their economic life cycle, and are expensive to operate (84% to 230% higher than the class average). Lead time is needed for the manufacturing process and for the specialized upfitting of the trucks. The order needs to be placed as soon as possible to ensure availability of equipment for the Bureau of Environmental Services.
- 4. The estimated cost of replacing these trucks is \$170,000 each, or \$510,000 for the three dump trucks. Funding is appropriated as an FY 2011 capital expense in the BES fund.
- 5. The City desires to purchase these replacement vehicles.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to issue a purchase order for these vehicles in accordance with City Code 5.33.
- b. The Mayor and City Auditor are hereby authorized to pay for said purchases from Bureau of Environmental Services funds.

Section 2. The Council declares that an emergency exists because a delay may result in additional expense to the City and to ensure availability of equipment for the Bureau of Environmental Services; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
