

**ORDINANCE NO. 184547**

\* Accept a 21<sup>st</sup> Century Grant award from the Portland Public School District to support activities for participants at Lane SUN Community Middle School. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Funding from Portland Public Schools for Lane SUN Community School will provide additional after-school programs for at least 100 at-risk students at Lane SUN Community School.
- 2. The grant funding of \$37,900 will cover programs from October 1, 2010 through August 30, 2011.
- 3. Activities will be focused and intensive after-school academic sessions in both language arts/reading and mathematics with certified teachers and educational assistants in small groups, in addition to enrichment activity choices such as musical theater and technology classes.
- 4. No match is required by this grant.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept a grant from the Portland Public School District for \$37,900 to support activities for participants at Lane SUN Community Middle School.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists in order to avoid further delay in Lane SUN Community School receiving the grant funds; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
