

ORDINANCE No. **184556**

*Authorize the City Attorney's Office to amend outside legal service agreements in the matter of Aaron Campbell v City of Portland et al. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City requires the services of outside legal counsel because of a conflict of interest in the matter of Estate of Aaron Campbell v City of Portland et al, USDC #CV10-1358 MO, Risk Management #G2010-0235-01 MS.
2. The law firms of Hoffman, Hart & Wagner LLP, Miller Wagner, LLP, Bill Blair PC, and Lehner Rodrigues LLP have agreed to provide these services.
3. Due to the nature of the matter, and the requirement to represent city employees by Outside Counsel when there is a conflict of interest, it is necessary to enter into agreements and amend them as required to increase the amount of the contract and/or extend the terms of the agreements.


NOW, THEREFORE, the Council directs:

- a. The City Attorney is authorized to enter into and amend, with the approval of Risk Management, outside legal service agreements with local law firms to represent named officers in the matter of Campbell v City of Portland et al.
- b. If applicable, the provisions of City Code Chapter 5.68 are waived.
- c. The Mayor and Auditor are authorized to draw and deliver warrants in payment of legal services provided under this ordinance.

Section 2. The Council declares that an emergency exists in order to continue to pay for legal services in a timely manner in the matter of Campbell v City et al; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
