

**ORDINANCE NO. 184560**

\*Accept a \$46,663 grant award from The Oregon Community Foundation Northwest Neighborhoods Parks and Recreation Sub-fund to renovate the kitchen at Hillside Community Center. (Ordinance)

Section 1. The Council finds:

1. Hillside Community Center serves more than 70 families through their pre-school program.
2. In 2003 the community center suffered fire damage when trash cans outside the kitchen caught fire. Due to a shortfall in funding, many of the former kitchen amenities were sacrificed in the subsequent renovation.
3. Currently, the center has only a small portable refrigerator, microwave and sink which limits program offerings for the pre-school program, and limits the types and number of groups interested in renting the facility for parties and events.
4. A complete renovation of the kitchen is needed.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept a grant from The Oregon Community Foundation Northwest Neighborhoods Parks and Recreation Sub-fund to renovate the kitchen at Hillside Community Center.

- b. The FY 2010/2011 budget is hereby amended as follows:

Bureau Program Expenses- **441100** = \$37,900

**511400** = \$28,550

- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists in order to avoid further delay in the Hillside Community Center receiving the grant funds; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
