* Authorize application to U.S. Department of Justice, Office of Justice Programs, National Institute of Justice for a grant in the amount of \$172,383 for the FY 2011 Paul Coverdell Forensic Science Improvement Grants Program (Ordinance)

2) Purpose of the Proposed Legislation:

The City of Portland, Oregon Police Bureau wishes to apply for U.S. Department of Justice (USDOJ), Office of Justice Programs (OJP), National Institute of Justice (NIJ) grant funding. The grant will allow the Police Bureau's Forensic Evidence Division to complete phase two of their conversion from 35 mm film to digital imaging technology with the purchase of a 360 degree digital laser scanning system. The grant period is October 1, 2011, through September 30, 2012.
