ORDINANCE No. 184570

*Accept a grant in the amount of \$870,000 from the Oregon Department of Transportation and authorize an Intergovernmental Agreement for the 122nd Complete and Green Main Street project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. 122nd Complete and Green Main Street project will improve pedestrian connectivity, access to transit, safety, accessibility, and leverage these transportation investments to stimulate economic development and private investments in the corridor.
2. The Portland Bureau of Transportation applied to the Oregon Department of Transportation (ODOT) for a grant in the amount of \$870,000 for right-of way acquisition for the 122nd Complete and Green Main Street project on November 12, 2010.
3. ODOT has notified the City of Portland that it will award a grant for the 122nd Complete and Green Main Street project to the Bureau of Transportation in the amount of \$870,000.
4. The Portland Bureau of Transportation is initiating design of the project to meet requirements for obligation of funds in the fall of 2011.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Transportation for the 122nd Complete and Green Main Street project in the amount of \$870,000 and to execute an Intergovernmental Agreement in substantially the form of the attached exhibit for this purpose.
- b. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
