# Intergovernmental Agreement

**AMENDMENT NO. 1  
IGA NO. 930179**

This Amendment hereby amends the above titled Intergovernmental Agreement between Metro, a metropolitan service district organized under the law of the State of Oregon and the Metro Charter, and The City of Portland, hereinafter referred to as "The City."

This amendment is a change order to the original Intergovernmental Agreement as follows:

The amount of the overmatch required by Metro of the City for the grant of CMAQ funds to support the SmartTrips North and Northeast program shall be reduced.

Change description:

**Term of Agreement: Project Description & Costs**, shall be amended to read:

2: The beginning date of this Agreement is July 1, 2010. The termination date of this Agreement is June 30, 2012. Costs incurred after June 30, 2010, which are deemed allowable costs for this project, will be reimbursed once all parties have signed this Agreement and Metro has been presented with the appropriate invoice and documentation.

4. The total Agreement amount, which consists of the federal grant dollars paid by Metro to the City and the required non-federal match by the City, is **TWO HUNDRED EIGHTY THREE THOUSAND FOUR HUNDRED NINETY AND NO/100<sup>TH</sup>S DOLLARS (\$283,490.00)**. The maximum amount of FTA funds to be dispersed to the City by Metro shall not exceed **ONE HUNDRED SEVENTY ONE THOUSAND FIVE HUNDRED TWENTY AND NO/100<sup>TH</sup>S DOLLARS (\$171,520.00)**.

5. The City shall be responsible for one hundred percent (100%) of the non-federal matching funds required and shall equal **NINETEEN THOUSAND SIX HUNDRED THIRTY ONE AND NO/100<sup>TH</sup>S DOLLARS (\$19,631.00)**. The City shall be responsible for additional project funds of **NINETY TWO THOUSAND THREE HUNDRED THIRTY NINE AND NO/100<sup>TH</sup>S DOLLARS (\$92,339.00)**. The maximum amount of funds to be contributed by the City shall be no less than **ONE HUNDRED ELEVEN THOUSAND NINE HUNDRED SEVENTY AND NO/100<sup>TH</sup>S DOLLARS (\$111,970.00)**.

Except for the above, all other conditions and covenants remain in full force and effect.


