

ORDINANCE No. 184617

* Amend subrecipient contract with Transition Projects, Inc. to add \$120,000 in one-time only funds to support the start-up operations of the Bud Clark Commons. (Ordinance; amend Contract No. 32000361)

The City of Portland ordains:

Section 1. The Council finds

1. The City of Portland passed Ordinance No. 184012 authorizing subrecipient Contract No. 32000361 with Transitional Projects, Inc (TPI) to provide outreach, emergency shelter, transitional shelter, permanent housing placement and other supportive services to homeless adults.
2. The opening of the Bud Clark Commons will provide the stated programs and services above and meet the goals and objectives of the Portland Housing Bureau (PHB).
3. Funding in the amount of \$120,000 in City General Funds will be added to this contract for a total amount not to exceed \$2,889,272 through the allocation of existing appropriations in PHB's FY 2010-11 Ending Homelessness Initiative budget.
4. The additional funds will be used to cover one-time only costs of opening the Bud Clark Commons, including staffing, moving and operational costs.

NOW THEREFORE, The Council directs:

- a. The Bureau Director and the City Auditor are hereby authorized to amend Subrecipient Contract No. 32000361 with TPI in accordance with the amendment attached as Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to make payment chargeable to the FY 2010-11 budget when demand is presented and approved by the proper authority.


