Street Count Instructions

- 4) Use <u>side A</u> if you are able to get answers to the survey questions.
 - Use <u>side B</u> (this side) if you <u>cannot</u> get answers, but the person is clearly sleeping outside.
- 5) Fill out one <u>side A</u> for each individual. For couples and families, attach forms together.

- This survey may be administered any time during the week of January 24-30, keeping in mind we want to know whereabouts on the night of Wednesday, January 26th.
- We can't use the data in the official count unless you collect the identifying information at the bottom of Side A (initials, age, gender).
