

ORDINANCE No. 184643

*Authorize License Agreement with Comcast for fiber optic installation at Washington Park.
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland owns Washington Park which is managed by Portland Parks & Recreation.
2. Comcast desires to install, operate and maintain a fiber optic installation underground on a portion of Washington Park.
3. Portland Parks & Recreation has negotiated a license agreement to permit Comcast to install a fiber optic installation.


NOW, THEREFORE, The Council Directs:

a. The Commissioner in Charge of Parks is authorized to execute a License Agreement with Comcast. The License Agreement will be substantially similar to the attached and approved as to form by the City Attorney.

Section 2. The Council declares that an emergency exists in order to avoid delay of the installation of this facility prior to other improvements to be done at the site; therefore, this Ordinance shall be in force and effect from and after its passage by Council.



