## ORDINANCE No. 3 4 8 4 6 4 4

\*Authorize Intergovernmental Agreement with the City of Gresham for management of the Gresham portion of the Springwater Corridor. (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. Portland owns the Springwater Corridor, which extends from the Willamette River to Boring, Oregon, with a portion of it located in the City of Gresham.
- 2. Pursuant to an expired 1992 Intergovernmental Agreement, authorized by Ordinance 164984, Gresham constructed that portion of the Springwater Trail that is in Gresham and has managed and maintained it since 1992.
- 3. Portland Parks & Recreation and the City of Gresham have negotiated a new Intergovernmental Agreement, with a term of 10 years, that sets out the terms and conditions for Gresham's continued management of the Springwater Trail in Gresham.

## NOW, THEREFORE, The Council Directs:

- a. The Commissioner in Charge of Parks is authorized to execute an Intergovernmental Agreement with the City of Gresham for management of a portion of the Springwater Corridor. The Intergovernmental Agreement will be substantially similar to the attached and approved as to form by the City Attorney.
- Section 2. The Council declares that an emergency exists in order to avoid any ambiguity regarding management of the Springwater Trail; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
