*Approve an Intergovernmental Agreement between Columbia County and the City of Portland for the distribution of equipment, supplies and services procured as a result of Urban Areas Security Initiative Grant funds. (Ordinance)

2) Purpose of the Proposed Legislation:

The City of Portland has been awarded an FY 2010 Urban Areas Security Initiative (UASI) Grant #10-170. The City of Portland is the official administrator for the UASI regional grants. Columbia County is a stakeholder in the UASI region. The FY 2010 UASI Grant award of \$6,874,736 (Ordinance #184474) is for addressing the unique planning, organization, equipment, training, and exercise needs of high-threat, high-density Urban Areas, and assist in building enhanced and sustainable regional capabilities to prevent, protect against, respond to, and recover from acts of terrorism.

The City of Portland needs to enter into an Intergovernmental Agreement with Columbia County. This agreement will utilize grant funds for the purchase and distribution of equipment, supplies and services procured as a result of UASI Grants
