

ORDINANCE No. 184669

Authorize contract with KPFF Consulting Engineers and provide for payment for the design and implementation of the SE Clay Green Street – 10th to Water Avenues Project No. E10007. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services pursued design and construction of projects to develop a safer connection from surrounding residential neighborhoods to the Willamette River using green streets. With a large residential neighborhood on the east end, and the Eastbank Esplanade and Willamette River on the west end, this project provides a significant opportunity to develop a safe bike and pedestrian connection to the Willamette River.
2. There is interest, Citywide, to construct green street facilities.
3. A consultant selection process has been conducted and KPFF Consulting Engineers was selected to provide Design Services for this project.
4. There is 20% M/W/ESB participation on this contract.
5. The estimated cost is \$230,390. Funds are available in the Sewer System Operating Fund, FY 2010-11 Budget, WBS Element E10007.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with KPFF Consulting Engineers for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
