ORDINANCE NO. 184673 As Amended

* Amend subrecipient contract with REACH Community Development Corporation to increase funding in the amount of \$15,600 to implement HUD Healthy Homes Production Grant. (Ordinance; amend Contract No. 32000428)

The City of Portland ordains:

SECTION 1. The Council finds that:

1. The City awarded funds to the REACH Community Builder Program for the 2010-2011 fiscal year to provide emergency home repair services to low-income elderly and disabled homeowners.
2. REACH Community Development Corporation (REACH CDC) was awarded additional funding under the HUD Portland Healthy Homes Production Grant to provide remediation of environmental hazards that can cause or exacerbate health conditions for low-income families.
3. Total compensation under this amended contract shall not exceed \$458,600.

NOW, THEREFORE, the Council directs:

- a. PHB's Director and the City Auditor are hereby authorized to enter a formal agreement with REACH in a form substantially in accordance with the agreement attached as Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to make payment chargeable to the FY 2010-2011 budget when demand is presented and approved by the proper authority.

SECTION 2. The Council declares that an emergency exists because delay in funding would interrupt REACH's ability to carry out the project; therefore, this ordinance shall be in force and effect from and after its passage by Council.
