*Amend outside counsel contract with Law Office of Erin Olson PC (Ordinance; amend Contract No. 30001578)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Portland Police Bureau required the services of outside legal counsel to provide legal services related to civil forfeiture.
- 2. The Law Office of Erin Olson PC agreed to provide these services by contract number 30001578, dated October 15, 2010.
- 3, Due to the nature of the work and success of the program, it is necessary to increase the amount of the contract.
- 4. To continue Counsel's work on these matters, it is necessary to extend the terms of the agreement until September 14, 2013.

NOW, THEREFORE, the Council directs:

- a. The City Attorney is authorized to extend Legal Service Agreement No. 30001578 to provide representation for the City of Portland in an additional amount of \$400,000, for a total not to exceed \$500,000.
- b. The terms of the agreement are extended to be in full force and effect through September 14, 2013.
- c. If applicable, the provisions of City Code Chapter 5.68 are waived.
- d. The Mayor and Auditor are authorized to draw and deliver warrants in payment of legal services provided under this ordinance.

Section 2. The Council declares that an emergency exists in order to continue to pay for legal services regarding civil forfeitures in a timely manner in the matter; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
