# Authorize contract with the Columbia Slough Watershed Council for \$215,000 for Columbia Slough-related outreach and education (Ordinance)

Due to an oversight in the ordinance, Item 642 was pulled from the Council agenda on June 22, 2011. The following changes are needed in Section 1, #5 of the ordinance. The amendment will be presented at the Council meeting on June 29, 2011.

Section 1 The Council finds:

5. Because of its standing in the community and the considerable benefits to the City of partnering with CSWC for community education and outreach services, it is in both the community's and the City's interest to contract with the CSWC for these services. <u>This sole source contract is being acquired as an exception to the competitive selection process identified in PCC 5.68 and the PTE Services Contracting Manual.</u>

Authorize contract with the Columbia Slough Watershed Council for \$215,000 for Columbia Slough-related outreach and education (Ordinance)

### 2) <u>Purpose of the Proposed Legislation</u>:

This legislation provides funding for the Columbia Slough Watershed Council to conduct outreach and education services. The Columbia Slough Watershed Council is a local non-profit organization. The community outreach and education that will be performed by the Watershed Council are consistent with actions identified within the *2005 Portland Watershed Management Plan*, adopted by Portland City Council on May 8, 2006.

### 3) <u>Revenue:</u>

This legislation will not generate or reduce current or future revenue coming to the City.

### 4) Expense:

The total cost of this amendment is \$215,000. Approximately \$38,000 will be used to fund services during FY 2012; \$39,000 will be used to fund services during FY 2013; \$40,000 will be used to fund services during FY 2014; \$41,000 will be used to fund services during FY 2015, and \$42,000 will be used to fund services during FY 2016. An additional \$15,000 will be available for restoration projects such as those identified in the *Columbia Slough Watershed Action Plan* and the *Portland Watershed Management Plan* and agreed to, in writing, by the City's Project Manager and the Watershed Council's Executive Director.

### I. RECOMMENDATION

Authorize contract with the Columbia Slough Watershed Council for outreach and education services.

### II. BACKGROUND

The Columbia Slough Watershed Council provides a crucial link to citizens, students, and businesses throughout the watershed. The City of Portland has collaborated with the Columbia Slough Watershed Council to protect, enhance, restore and revitalize the Columbia Slough and its watershed for over a decade.

The Watershed Council is actively involved in numerous watershed events throughout the year including: watershed restoration and clean-up events, paddling tours, educational workshops, and a volunteer-based watershed monitoring program. Over five thousand students annually benefit from the Watershed Council's 'Slough School' program. There are also annual activities directed at Portland's immigrant and refugee populations.

Continued funding for the Columbia Slough Watershed Council will enable the council to implement their work plan within the City of Portland and is expected to enable the Watershed Council to leverage additional funds from other sources. City support will lead to healthier watershed, increased watershed awareness, and increased public stewardship.

### III. FINANCIAL IMPACT

The total cost of this ordinance is \$215,000; these funds are to be divided throughout a five year period (July 1, 2012 – June 30, 2016). These funds will be derived from the Sewer System Operating Fund for the fiscal years of 2012 - 2016.

### IV. LEGAL ISSUES

The Columbia Slough is a water quality limited water body. Legal issues and requirements for the City of Portland include: Department of Environmental Quality (DEQ) 303(d) listing, DEQ

Total Maximum Daily Loads (TMDL), and Oregon Department of Fish and Wildlife threatened species listings (the Lower Columbia Slough provides refuge for listed salmonids).

### V. CONTROVERSIAL ISSUES

There are no known groups or individuals opposed to this ordinance.

The Columbia Slough Watershed Council is a diverse group of neighbors, property owners, businesses, environmental groups, recreation advocates, and government agencies, all of whom would be supportive of this ordinance. In light of the fact that 5,000 students participate in free science-based Columbia Slough Watershed Council education programs yearly, it is assumed that Portland Public Schools would also be supportive of this ordinance.

### VI. LINK TO CURRENT CITY POLICIES

Funding the Columbia Slough Watershed Council is consistent with the goals of many current City policies, including: the *Portland Watershed Management Plan* and the *Portland Plan*.

### VII. CITIZEN PARTICIPATION

The main objective of the Watershed Council is developing and utilizing community involvement to further watershed improvement and awareness. Residents, businesses, schools, and agencies are the focus of the Watershed Council's outreach and involvement efforts. There are over 20 active board members on the Watershed Council. Neighborhood and business associations are included in all Watershed Council outreach. The Watershed Council coordinates an annual event, *¡Explorando!*, that draws hundreds of immigrants and new Portland arrivals as well as hosts the *Regatta*, the largest one day recreational boating event in Oregon on the Columbia Slough.

More than two thousand citizens participate in Columbia Slough Watershed focused activities each year. In addition, each year over five thousand students participate in free Columbia Slough Watershed Council science-based education programs.

The Watershed Council is also a model for international efforts to involve citizens in environmental decisions and solutions. Visitors from more than 25 countries have studied its methods while in Portland.
