The purpose of this legislation is to apply for the FY 2011 UASI grant. The Department of Homeland Security provides financial assistance to selected urban areas through the FY 2011 Urban Areas Security Initiative (UASI). The City of Portland, in cooperation with regional partners (TriMet, Port of Portland, Multnomah, Clackamas, Washington and Columbia Counties of Oregon and Clark County, Washington) is applying for financial assistance to address the unique equipment, training, planning, exercise and operational needs of large urban areas.

If the grant is awarded, it would increase City appropriation by \$4.9 million, a portion of which would be resources for City bureaus and a portion of which would be resources allocated for non-City of Portland jurisdictions. The funds would not be appropriated until FY 2012-13. There is no match requirement for this Grant award.

A portion of grant funds will be allotted to projects for the Portland Urban Areas Security Initiative (UASI) Citizen Corps Working Group (CCWG).

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

The CCWG works to build disaster resilient communities throughout the Urban Area by leveraging and sharing resources to develop and support regional projects, as well as local initiatives. Its objectives include:

- Enhance disaster preparedness and awareness by doing community outreach
- Recruit, train, and support citizens to respond appropriately during disasters
- Engage citizens in volunteer service through our Citizen Corps programs
- Integrate citizen participation into UASI training and exercise

The CCWG is comprised of a designated representative from each of the primary UASI jurisdictions (Clackamas County, Columbia County, Multnomah County, Washington County, City of Portland, and Clark County Washington). The county representative is responsible for representing all citizen corps programs within that jurisdiction. Each of the CCWG representatives has one vote. The vote represents the representative's jurisdiction. The CCWG members may create subcommittees as needed for detailed and large projects.

c) How did public involvement shape the outcome of this Council item?

The CCWG presented projects to the Urban Area Working Group (UAWG). The UAWG determines the distribution of grant funds to the various Working Groups for the Portland Urban Area.

d) Who designed and implemented the public involvement related to this Council item?

The CCWG designed their portion of the projects to be funded with this grant.
