

ORDINANCE No. 184733

- * Authorize Intergovernmental Agreement with the City of Gresham for the joint operation of Station 31 (Ordinance; Contract No. 30002163)

The City of Portland ordains:

Section 1. The Council finds:

1. By Ordinance No. 173552, passed July 7, 1999, the cities of Portland and Gresham are sharing the operation of Portland Fire Station 31, located at 1927 SE 174th St.
2. By Ordinance No. 181273, passed September 12, 2007, the 1999 agreement was substantially modified to meet changing service demands.
3. The 2007 agreement expired on June 30, 2009.
4. By Ordinance No. 183088, passed on August 12, 2009, a new agreement was reached, authorizing the shared operation until the Station was closed for demolition and construction of a new Fire Station.
5. As part of the 1998 G.O. Bond, Station 31 has been demolished and rebuilt on the same site.
6. The new Station 31 will be ready for operation on or about July 1, 2011.
7. Both the City of Gresham and City of Portland would like to enter into a new agreement for the shared operation of the new Station 31.
8. The provisions of ORS 190.010(3) authorize the City to enter into this agreement with the City of Gresham.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-Charge and the Auditor are authorized to execute an agreement for the operation of Station 31 with the City of Gresham in substantially the form set forth in Exhibit A, attached to this Ordinance.

Section 2. The Council declares that an emergency exists because the new Station will be available for use on or about July 1, 2011. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
