Adopt revision to Basic Emergency Operations Plan (Resolution)

WHEREAS, the Portland Office of Emergency Management is responsible for the emergency preparedness, response and recovery planning of the City of Portland; and

WHEREAS, the Basic Emergency Operations Plan (BEOP) outlines the framework for coordinated response and efficient use of City resources during emergencies and major disasters; and

WHEREAS, The BEOP is the core document of the City of Portland Comprehensive Emergency Management Plan (CEMP) and is an all-hazards plan describing how the City's emergency management system is organized to respond to emergencies; and

WHEREAS, the City is responsible for city owned assets and infrastructure and the services performed as described in the City Code Chapters 3.124, 3.125 and 3.126 and Chapter 15.04 and 15.08 as amended; and

WHEREAS, The Disaster Policy Council recommends the adoption of the Basic Emergency Operations Plan with its changes as shown in Exhibit A.

NOW, THEREFORE, BE IT RESOLVED, that the City of Portland adopts the Basic Emergency Operations Plan as Non-Binding policy attached as Exhibit A.
