No targeted public involvement was included for this grant application, specifically, but the culvert replacement work in Crystal Springs has included a great deal of outreach with the community. To date, BES partnered with Reed College to replace the culvert at SE 28th Avenue. Like the SE 28th culvert project, upcoming culvert replacement projects will include a comprehensive public involvement effort (described in greater detail below). On a watershed-wide scale, BES is forming partnerships in the Crystal Springs community with help from Portland State University to build a base of stewardship in the community around watershed health. With this grant, Bureau of Environmental Services will continue its work to leverage Grey to Green culvert replacement funding to replace <u>all</u> fish passage barriers along Crystal Springs Creek. To date, BES has partnered with Reed College to replace the culvert at SE 28th Avenue. The City received money from National Marine Fisheries Service and Metro to restore passage at SE Umatilla St., a private (now City owned) carport, and SE Tenino St. The City is partnering with the Army Corps of Engineers to construct those projects, as well as restore passage at SE Tacoma Street and restore and enhance the stream through Westmoreland Park. The City has partnered with Tri-Met to mitigate wetland impacts at Westmoreland Park, and discussed restoration of the railroad culvert with Union Pacific. If all of these efforts are successful, the

City will still have enough funding to design and partially construct replacement culverts at SE Bybee and SE Glenwood, completing the effort by 2013.

Public involvement is crucial to building a base of support for these and other watershed restoration projects in the City. For each project, targeted public involvement activities include direct communication with property owners adjacent to construction activities, haul routes, and staging areas. Neighbors within project areas receive project update letters throughout the planning and design process. Additionally, BES staff (and any partners) attends neighborhood association and business association meetings as necessary to communicate construction impacts, traffic impacts, and overall project goals. BES staff also provides opportunities for public feedback during open house and coffee klatch events.

For this culvert replacement project at Eastmoreland Golf Course, Ronda Fast (Environmental Program Coordinator) will develop a public involvement plan with the Project Manager, Chad Smith and Parks Superintendent for the Golf Course (Parks Bureau) to devise a public involvement plan and begin implementation Fall of 2011.

These individual culvert projects have led to a much larger watershed community stewardship effort that is being spearheaded by Portland State University through their Neighborhoods and Watersheds Capstone. The students are engaged in community organizing and awarenessbuilding around watershed health. Their work supports a community-led organization called the Crystal Springs Community Collaborative, a group of community members focused on education, advocacy, and restoration in the watershed.
