

ORDINANCE NO. 184749

*Authorize application to U.S. Department of Housing and Urban Development, Office of Community Planning and Development, Office of HIV/AIDS Housing for a grant in the approximate amount of \$1,375,000 to advance HUD's implementation of the National HIV/AIDS Strategy. (Ordinance)

Section 1. The Council finds:

1. The U.S. Department of Housing and Urban Development has made available a Notice of Funding Availability for providing housing assistance and supportive services and comprehensive planning and coordination of local resources in meeting housing and service needs for People Living with HIV (PLWH).
2. The Portland Housing Bureau is responding to the Notice of Funding Availability with an application for approximately \$1,375,000 in federal funds, to be spent over three years.
3. No match is required by this grant.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to make application to the U.S. Department of Housing and Urban Development for a grant in the approximate amount of \$1,375,000.
- b. The Mayor is authorized to provide such information and assurances as are reasonably required by the U.S. Department of Housing and Urban Development for the grant period.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because the grant must be submitted no later than August 2, 2011. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
