**ORDINANCE No.**

- \* Authorize contract with Alder Creek Lumber Company, Inc., for fire prevention, suppression and emergency response services for FY 2011-2012 (Ordinance, Contract 30002151)

The City of Portland ordains:

Section 1. The Council finds:

1. Alder Creek Lumber Company, Inc., an Oregon corporation, has requested that the City provide fire prevention, suppression, and emergency response services for their property on the terms and conditions described in Exhibit A, attached to this Ordinance.
2. The City, through Portland Fire & Rescue, is willing to provide these services to Alder Creek Lumber Company, Inc. as requested and on the terms and conditions set forth in Exhibit A.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge and the City Auditor are authorized to enter into an Agreement for fire prevention, suppression, and emergency response services with Alder Creek Lumber Company, Inc., for the term beginning July 1, 2011 and continuing through June 30, 2012 for the sum of \$2,256.00 paid by Alder Creek Lumber Company, Inc., on the terms and conditions set forth in the Agreement, a copy of which, marked Exhibit A, is attached to this Ordinance.

Section 2. The Council declares that an emergency exists because the current agreement expired June 30, 2011; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
