-history of project - Alder Creek Lumber Company (Alder Creek) is a duly registered corporation. It has its operations outside the boundaries of Portland Fire & Rescue's (PF&R) jurisdiction. For the past twenty-five (25) years, rather than rely solely on the resources of the rural fire district serving its location Alder Creek has asked PF&R to provide fire prevention and suppression, and emergency medical response services at its property located at 14456 NW Gillihan Rd. Alder Creek pays an annual fee for these services based on its tax assessed value. This is an emergency ordinance because the current contract expired on 6/30/11.
