## 184771 ORDINANCE No.

\* Designate City-owned property along Waud Bluff for park purposes and assign to Portland Parks & Recreation (Ordinance).

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The City owns a 9.11 acre parcel (the "Property"), identified as 1N1E17B 100, adjacent to Willamette Blvd. that is part of Waud Bluff.
- 2. Portland Parks & Recreation ("Parks") requires a portion of the Property to build the Waud Bluff trail, which begins on the Property and continues to the southwest.
- Parks is willing to take on management of an approximately 3.6 acre portion of the 3. Property, as described below and depicted in Exhibit A to this ordinance.
- 4. The Property is not assigned to any City bureau at this time and the Office of Management and Finance supports assigning a portion of the Property to Parks.

## NOW, THEREFORE, The Council Directs:

- a. The portion of the Property depicted in Exhibit A, which consists of that portion of 1N1E17B 100 that is to the west of the centerline of Menlo Street extended southerly, is designated for park purposes and assigned to Parks.
- b. Parks shall have all maintenance and management responsibilities for the property assigned to it by this ordinance.
- c. Council acknowledges the need to fund the ongoing maintenance costs, estimated at \$7,000 per year, and directs this ongoing funding allocation from the General Fund to the Parks budget beginning in FY2011-12 to be initiated by a Parks' request in the FY2011-12 Fall BuMP.

Section 2. The Council declares that an emergency exists because a delay in designating and assigning the property to Parks may result in delays in construction of the trail; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
