

ORDINANCE No. 184793

*Authorize grant agreement with the Miracles Club for peer-to-peer drug and alcohol recovery mentoring services (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Miracles Club provides invaluable services to individuals and families dealing with drug and alcohol addiction issues in our community and many of the City's social service organizations refer individuals to Miracles Club.
2. Funds are available for this grant and were appropriated in the FY 2011-12 Adopted Budget as a Special Appropriation (SA_23).
3. The Miracles Club will use the grant of \$10,000 to provide peer-to-peer drug and alcohol recovery mentoring services.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Affairs is authorized to enter into an Agreement with the Miracles Club as substantially set forth in Exhibit A attached to this ordinance.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to FY 2011-12 Adopted Budget Special Appropriation SA_16, in an amount not to exceed \$10,000 once the grant agreement is executed.

Section 2. The council declares that an emergency exists because a delay in authorizing this portion of the grant funds could cause the Miracles Club a delay in delivering services; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
