

ORDINANCE No. 184795

Authorize a contract and provide for payment for the construction of the Washington Park Sewer Rehabilitation Project No. E10103 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Approximately 1,700 feet of combined sewer main in the Washington Park between SW Sherwood Blvd and W Burnside St will be repaired using Cured-In-Place-Pipe (CIPP), pipe bursting, and open cut excavation.
2. Environmental Services has prepared plans and specifications for rehabilitating the sewers manholes, service laterals, and inlets.
3. Environmental Services requires the furnishing of materials and labor for this project.
4. The estimated cost is \$520,000. The level of confidence in this estimate is high. Funds are available in the Bureau of Environmental Services Sewer System Operating Fund, FY 2011-2012, Project No. E10103.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1, in the amount of \$ 520,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
