

ORDINANCE No. 184807

*Authorize application to the Oregon Department of Land Conservation and Development for a periodic review grant in the amount of \$173,000 for the State fiscal biennium of July 1, 2011 to June 30, 2013 to update elements of the City Comprehensive Plan (Ordinance)

The City of Portland Ordains:

Section 1. The Council finds:

1. On August 11, 2008 the Portland City Council transmitted a periodic review work program to the Oregon Department of Land Conservation and Development (DLCD) to update the economic development, housing, public facilities, transportation, and urbanization elements of the City's Comprehensive Plan.
2. On September 30, 2009 the Director of DLCD approved Portland's periodic review work program. This approval made the Portland Bureau of Planning and Sustainability eligible for periodic review grants.
3. On July 25, 2011 DLCD announced the availability of a grant program, stating that the highest priority would be funding of approved periodic review work tasks.
4. No match is required by this grant. If the grant is approved by DLCD and accepted by City Council, the Bureau of Planning and Sustainability will identify the salary, benefits and services to be provided by staff within the FY 2011-2012 and FY 2012-2013 budget appropriations.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to apply to DLCD for a Periodic Review Grant in the amount of \$173,000 for the State Fiscal Biennium of July 1, 2011 to June 30, 2013.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant application.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf

Section 2. The Council declares that an emergency exists because the DLCD announced the availability of periodic review grant funding on July 25, 2011, and requires the City to submit its grant application by September 1, 2011.
