

ORDINANCE No. 184809

Consent to change in business organization of J&R Weisenfluh Sanitary Service, from a general partnership to a limited liability company. (Ordinance)

The City of Portland ordains:

Section 1 the Council finds that:

1. In 2002, the Council approved Ordinance No. 176687 granting a residential solid waste collection franchise to J&R Weisenfluh Sanitary Service organized as a general partnership.
2. Weisenfluh's franchise establishes terms and conditions for the company's delivery of residential solid waste and recycling services within a particular geographic territory of the City.
3. As one of the franchise conditions, Weisenfluh Sanitary Service agreed that it would not assign or transfer the franchise, by any means, without the consent of the City. Section 14 of Ordinance No. 181666 implements Section 10-216 of the Portland City Charter, which requires that franchise transfers are subject to consent from the Council.
4. Weisenfluh Sanitary Service has decided to change their business structure from a general partnership to an LLC (Oregon limited liability company) as of October 1, 2011. Weisenfluh Sanitary has requested that the City give its consent to this change of business structure.
5. The staff at Bureau of Planning and Sustainability recommends that the Council approve the change.

NOW THEREFORE, The Council directs:


