The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 184684 passed Council on June 22, 2011 amending the outside counsel agreement with the Law Office of Erin Olson.
2. The ordinance passed, but included a typographical error in point a. of the Council's directive.
3. The corrected point a. should read as follows: The City Attorney is authorized to extend Legal Service Agreement No. 30001578 to provide representation for the City of Portland in an additional amount of \$405,000, for a total not to exceed \$500,000.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 184684, Point a of Council directive is amended to read as follows:

The City Attorney is authorized to extend Legal Service Agreement No. 30001578 to provide representation for the City of Portland in an additional amount of \$405,000, for a total not to exceed \$500,000.


- b. All other terms and provisions of Ordinance No. 184684 remain the same and are not affected by this amendment.
