

ORDINANCE No. 184831

- \* Authorize agreement with the State of Oregon, Office of the State Fire Marshal, for Regional Hazardous Materials Emergency Response Team Services. (Ordinance; Contract 30002260)

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Fire & Rescue (PF&R) participates in a regional hazardous materials emergency response team within the boundaries of the Emergency Response Area, when requested by the State Fire Marshal (OFM).
2. It is necessary that the agreement between the OFM and the City be updated and executed as soon as possible, substantially on the terms and conditions outlined in Exhibit A, attached hereto.
4. The Fire Chief recommends that the City execute this Agreement, and states that participation on the Regional Hazardous Materials Team will not impair the ability of PF&R to protect the citizens of Portland.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner of Public Works and the City Auditor are authorized to execute this Intergovernmental Agreement for Regional Hazardous Materials Emergency Response Team Services for participation by Portland Fire & Rescue for biennium 2011-2013, substantially in accordance with Exhibit A, attached hereto.

Section 2. The Council declares that an emergency exists because the current Agreement expired on June 30, 2011; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
