

ORDINANCE No. 184838

*Authorize an Intergovernmental Agreement with Portland State University for \$10,000 in support of the First Stop Portland program to provide services of logistics and coordination for visiting delegations. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

1. The public interest of the citizens of the City of Portland is served by a coordinated program hosting visiting delegations interested in Portland's practices in planning and sustainability.
2. Portland State University, through the College of Urban and Public Affairs (PSU CUPA), manages a program called First Stop Portland that provides services in logistics and coordination of these delegations, thus relieving city staff of this responsibility.
3. The City's financial assistance of \$10,000 to PSU CUPA for this program is consistent with City authority and functions under its Charter. Funds exist in the FY 11-12 budget for the Bureau of Planning and Sustainability, Cost Center PNSD000002.
4. The City wishes to enter into the attached Intergovernmental Agreement, Exhibit A, with PSU CUPA to organize and coordinate tours of visiting delegations interested in Portland's practices in planning, sustainability and promotion of the City's livability.

NOW, THEREFORE, the Council directs:


- a. The Director of the Bureau of Planning and Sustainability is hereby authorized to enter into an intergovernmental agreement with PSU CUPA for \$10,000 in funds in a form substantially in accordance with the agreement attached as Exhibit A to this ordinance.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the FY 11-12 budget for the Bureau of Planning and Sustainability, SD8000001 upon the passage of this ordinance.

Section 2. The Council declares that an emergency exists to avoid a delay in providing funding to PSU CUPA for services; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
