

ORDINANCE No. 184841

*Authorize an Intergovernmental Agreement with Oregon Department of Transportation to define the roles and responsibilities for real property to be obtained and used as a part of right-of-way for the SE 122nd Ave Complete and Green Main St project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. 122nd Complete and Green Main Street project will improve pedestrian connectivity, access to transit, safety, accessibility, and leverage these transportation investments to stimulate economic development and private investments in the corridor.
2. The Portland Bureau of Transportation applied to the Oregon Department of Transportation (ODOT) for a grant in the amount of \$870,000 for Right Of Way acquisition for the 122nd Complete and Green Main Street project on November 12, 2010.
3. The City of Portland and ODOT executed an Intergovernmental Agreement to accept funds for the 122nd Complete and Green Main Street project to the Bureau of Transportation in the amount of \$870,000 on May 11, 2011.
4. The Portland Bureau of Transportation is initiating design of the project to meet requirements for obligation of funds in the Fall of 2011. Right-of-way funds must be obligated before October 1, 2011; however, right-of-way acquisition will not begin until the design of the project has been completed.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-Charge and the Auditor are hereby authorized to enter into an Intergovernmental Agreement with the Oregon Department of Transportation for the SE 122nd Ave Complete and Green Main Street project, substantially in accordance with the agreement attached to the original of this ordinance, and, by reference, made a part hereof.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant and meet obligation timelines; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
